HAVE GRANTED, conveyed and released, and by these presents DO GRANT convey and release unto the said Leroy Massengale and Myrtle C. Massengale, as Trustees for Byron/All that right, title and interest of Janice Smith, a minor, the same being an undivided 1/33 interest in and to the following described property:

ALL that piece, parcel, or tracts of land, situate, lying, and being in the State of South Carolina, County of Greenville, Oneal Township, and according to the plat prepared by Terry T. Dill, RLS, on April 12, 1974, for Edna C. Sloan Estate, as having the following metes and bounds, to-wit:
