
BEGINNING at a point in the center of bridge on Miller Road, spanning South Tyger River, and thence with the center line of the river as the line, the traverse lines of which are S. 06-31 E. 103.3 feet to a point; thence N. 35-55 W. 211.4 feet to a point; thence S. 69-03 W. 230 feet to a point; thence S. 00-31 W. 109.6 feet to a point; thence N. 7-30 E. 211 feet to an iron pin; thence still with the center line of the river, the traverse lines of which are S. 09-19 W. 305.5 feet to a point; thence N. 34-45 W. 163 feet to a point; thence N. 20-30 W. 161 feet to an old iron pin; thence along the boundary of Paul Green (or formerly) property N. 36-15 E. 507 feet to old iron pin; thence N. 29-05 W. 207 feet along southern boundary of Clark Lathers (or formerly) property to new iron pin; thence S. 14-10 W. 312.7 feet to new iron pin; thence S. 06-10 E. 611 feet to center of Miller Road; thence along S. 21-11 Miller Road on an angle, the chord of which is S. 2-45 W. 19.4 feet to a point; thence further along said road on an angle, the chord of which is S. 4-15 E. 11.2 feet to a point; thence along the center of said road S. 1-21 E. 137.0 feet to point in center of bridge spanning "South Tyger River," the width of the river, and containing 12.39 acres, more or less.
