KNOW ALL MEN BY THESE PRESENTS that I, We, BRUCE M. BURNS and DONNA B. BURNS of the County of Greenville in the State aforesaid, in consideration of the sum of One Dollar (\$1.00) and other valuable consideration to us in hand paid by the United States of America, acting through the Administrator of the Farmers Home Administration, the receipt of which is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant, bargain, sell and release unto the said United States of America, the following described property situated in Greenville County, State of South Carolina, to-wit:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 4 of Caravelle Sub-division, and, according to a plat prepared of said Subdivision by R. B. Bruce, Reg. L.S., February 10, 1972, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4N, at Page 61, having the following courses and distances, to-wit:  
BEGINNING at a point on the edge of McElhaney Road, joint front corner of Lots Nos. 4 and 5, and running thence with the line of said lots, N. 18-35 W. 149.1 feet to an iron pin; thence, N. 85-26 E. 88 feet to an iron pin; thence, S. 18-15 E. 152.4 feet to a point on the edge of McElhaney Road; thence running with said road, S. 87-38 W. 88 feet to a point, the point of beginning.
