The right of way is to and does convey to the grantee, its successors and assigns the following: The right and privile, of entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manhole and any other adjuncts deemed by the grantee to be necessary for the purpose of conveying sanitary sewage and industry wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same frow time to time as said grantee may deem desirable; the right at all times to cut away and keep clear of said pipe lines any at all vegetation that might, in the opinion of the grantee, endanger or injure the pipe lines or their appurtenances, or integers with their proper operation or maintenance; the right of ingress to and egress from said strip of land across the lar referred to above for the purpose of exercising the rights herein granted; provided that the failure of the grantee to exercise any of the rights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time are from time to time to exercise any or all of same. No building shall be erected over said sewer pipe line nor so close there as to impose any load thereon. 3. It is further agreed: That in the event a building or other structure should be erected contiguous to said sewer pip line, no claim for damages shall be made by the grantor, his heirs or assigns, on account of any damage that might occur t such structure, building or contents thereof due to the operation or maintenance, or negligences of operation or maintenance, or said pipe lines or their appurtenances, or any accident or mishap that might occur therein or thereto.
