sell and release unto South Carolina State Highway Department, its successors and
assigns, forever:

ALL that piece, parcel or tract of land on the southern side of Madison Street
in the City of Greenville, County of Greenville, State of South Carolina, shown
on a Plat entitled "Property of the Borden Co., Greenville Ice Cream Division",
by Piedmont Engineers dated December, 1954, said Plat being recorded in the
RMC Office for Greenville County in Plat Book VV, at Page 85, and having,
according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Madison Street, which pin is
located 150 feet in a south west direction from the south west corner of the
intersection of West Washington Street and Madison Street and running thence
S. 34-06 E. 86 feet to an iron pin in line of property now or formerly of the
Borden Co.; thence with the line of said Borden Co. property S. 55-26 W. 20
feet to an iron pin; thence continuing with the line of said Borden Co. pro-
perty N. 34-06 W. 86.1 feet to an iron pin on the southern side of Madison
Street; thence with the southern side of Madison Street N. 56-15 E. 20.05
