of Sale, heretofore executed by the marties to this deed, any transfer of the momenty or any mart thereof, or any change in the ownership or distribution of the stock of the Purchaser, or with respect to the identity of the marties in control of the Purchaser or the degree thereof, and such violation shall not be cured within sixty (60) days after written demand by the Agency to the Purchaser, the Agency shall have the right to re-enter and take possession of the property and to terminate (and revest in the Agency) the estate conveyed by this deed to the Purchaser; provided, that any such right of re-entry shall always be subject to and limited by, and shall not defeat, render invalid, or limit in any tay:
