In consideration of the sum of five dollars, hereinafter set out, and other things in this deed contained, the receipt of which is hereby acknowledged, and for the purpose of creating a right-of-way easement, the undersigned, Donnie S. Tankersley, R.H.C., of the County of Greenville, State of South Carolina, do hereby grant to the Southern Bell Telephone and Telegraph Company, its successors, assigns, and assigns and authorized representatives, a right-of-way easement for the use of the telephone and telegraph lines and related facilities, including, but not limited to:

- (1) poles, guys, anchors, aerial cables and wires;
- (2) ~~underground cables and wires, conduits, manholes, soling boxes and pedestals;~~
- (3) ~~conduits, manholes, manholes, underground cables and wires;~~
- (4) ~~and other appurtenances, and any other devices.~~

to have and under a strip of land 10 feet wide and as the following lands in Greenville County, State of S.C., generally described as follows: THAT TRACT OF LAND BELONGING TO LLOYD PLUMBLEY

Bounded on the North by the Greenville Water Shed, on the South by the Property of Ella Plumley and on the South and West by the Property of Garrison Plumley

and, to the fullest extent the undersigned has the power to grant, if at all, over, along and under the mass, streets or highways adjoining or through said premises.

The following rights are also granted: to allow any other person or company to attach wires or cable or conduit within the right-of-way for power, lighting or electric power transmission or distribution; ingress and egress to said premises at all times; to clear the land and keep it free of all trees, undergrowth or other obstructions within the easement area; to trim and cut and keep trimmed and cut all dead, weak, leaning or dangerous trees or limbs outside of the easement area which might interfere with or fall upon the lines or systems of distribution and power transmission or distribution.

The receipt of ONE and NO dollars and 10<sup>00</sup> cents is hereby acknowledged by the undersigned.

To have and to hold the above granted easement unto Southern Bell Telephone and Telegraph Company, its successors and assigns forever.
