of such new Lesse, less the net income collected by Lessor subsequent to the date of termination of this Lesse and prior to the execution and delivery of the new Lesse, any excess of such net income over the aforesaid sums and expenses to be applied in payment of the net fixed rental thereafter becoming due under said new Lesse,

(iii) Upon the execution and delivery of such new Lease in accordance with the provisions hereof, all sublesses which theretofore may have been assigned and transferred to Lessor shall thereupon be assigned and transferred without recourse by Lessor to the Lessehold Mortgages, as the new tenant,

- (1) In the event the Lessehold Mortgages shall become the holder and legal owner of the Lesses's interest in the Lesse in accordance with the terms and provisions hereof, it is understood that the Lessehold Mortgages may sublet and assign the Lesse without first obtaining the consent of the Lessor.
- (m) In the event the Leasehold Nortgages should not remedy any default within the time set forth herein or not cause the default to be remedied by the Leasee within the foregoing time periods, or not exercise its rights and privileges under sub-paragraphs (f) through (l) hereof, the Lessor shall have the right to make a declaration of default and have the right of reentry, and the Lessor shall further have the following options, any one of which may be elected by written notice directed to the Lessee and mailed within ten (10) days after such re-entry:
- (1) The right to completely terminate the Lease fully terminating the liability of all parties thereunder; or
- (2) To declare the rent for the entire remaining period of the Lease immediately due and payable. If this option is elected, the Lessor agrees to pay over to the Lessee the net rentals received for the balance of the base term, from any reletting affected by the Lessor after deducting all costs incurred in connection with such re-entry and re-letting; or WDP, ATTY.
