B. Williams and Janet D. Williams to Deaver B. Williams, Jr. and Helen T. Williams, recorded in Deed Book 555 at Page 443 in the Office of the Register of Mesne Conveyance of Greenville County, South Carolina; thence from said beginning point South 55 degrees 43 minutes West 395 feet to an iron pin, said iron pin being the Southwestern corner of the tract herein conveyed; thence North 27 degrees 16 minutes West (passing an iron pin at 544 feet and passing another iron pin at 613 feet) 650 feet to a point located in the old Tugaloo Road, said point being designated by an iron pin offset South 27 degrees 16 minutes East 37 feet; thence with said road North 55 degrees 34 minutes East 328 feet to a point in said road; thence with the line of the property now or formerly belonging to Henson South 33 degrees 37 minutes East 645 feet to the point of BEGINNING, containing 5.0 acres, as shown and delineated upon an unnamed plat which was prepared for Deaver B.
