


ALL that piece, parcel or lot of land designated as Lot 30 of Buxton Subdivision, as shown on two (2) plats entitled Buxton and Addition to Buxton, said plats being prepared by Piedmont Engineers and Architects and dated November 5, 1970, and which plats are recorded in Plat Book 4-N at Pages 2, 3 and 4, according to said plats, the lot is described as follows:

BEGINNING at an iron pin at the joint corner of Lots 30 and 32; thence N. 33-46 W. 179.8 feet to an iron pin; thence N. 38-19 E. 81.15 feet to an iron pin; thence S. 52-50 E. 162.5 feet to an iron pin; thence in the roadway, joint front corner of Lots 30 and 29; thence with said roadway S. 36-14 W. 65.6 feet; thence continuing with said roadway S. 33-33 W. 74.4 feet to the point of beginning.

This conveyance is made subject to the restrictions recorded in Deed Book 910 at Page 491, easements, setback lines and rights-of-way found in Plat Book 4-N at Page 2 and such other easements, rights-of-way as may be of record.
