Hunt Estate, made by H. S. Brockman, Surveyor, dated October 16, 1951, reference to which plat is craved for the location of said water lines and appurtenances.
The license granted hereunder is for the sole benefit of the Grantee herein, and by the acceptance thereof, the Grantee assumes no duty or obligation to any party to supply water to any persons presently being serviced by said lines, it being recognized that water pressures in said lines are inadequate for proper domestic service or fire protection; nor shall the acceptance of said license create any duty or obligation on the part of the Grantee herein to allow further tap-ons to said water system for the purpose of supplying water to additional consumers or any other expansion of said system.
