the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the City of Greenville, a Municipal Corporation, its successors and assigns forever,

ALL that piece, parcel or lot of land in the City of Greenville, County and State aforesaid, on the South Side of South Main Street and having the following metes and bounds to wit:

BEGINNING at an iron pin on said South Main Street corner of property now or formerly of K. S. Conrad, and running thence with Conrad's line S 28-07 E 165 feet, more or less, to an iron pin; thence S 77-18 W 53.9 feet, more or less, to an iron pin; thence N 20-58 W 155 feet, more or less, to an iron pin on South Main Street; thence with said Street N 68-59 E 32.1 feet, more or less, to the beginning corner. BEGINNING at an iron pin on the Southeast side of South Main Street and on eight (8) foot walkway which extends in a Southeasterly direction along the northeastern line of lot formerly owned by W. H. Irvine and described in agreement of February 12, 1912, between Vardry Cotton Mill and W. L. Gassaway, and Davis Furman recorded in Deed Book 12, at Page 277, and running thence along the walkway S 30-40 E 135 feet, more or less, to the center line of a railway spur tract as shown on plat made by A. H. Porter, Engineer, April, 1911 and described in a certain agreement of June 29, 1912 between Charleston and Western Carolina Railway Company and Main Street Land Company, recorded in the RMC Office for Greenville County in Deed Book 12 at page 417; thence with the Center line of said spur tract in a northeasterly direction approximately parallel with Main Street 50 feet, more or less, thence parallel with the walkway above mentioned N 30-40 W 135 feet, more or less, to South Main Street; thence with South Main Street in a Southwesterly direction 50 feet, more or less, to the beginning corner.
