 - 3. The property referred to by this agreement is described as follows:

All that lot of land in Greenville County, State of South Carolina, on the Southeast side of Kirkwood Lane, in the City of Greenville, being shown as lot 146, on plat of Isaqueena Park, recorded in Plat Book P at Pages 130 and 131, and described as follows:

Beginning at a stake on the Southeast side of Kirkwood Lane, 190 feet Northeast from DuPont drive, at corner of lot 105, and running thence with the Southeast side of Kirkwood lane, N. 144-09 E. 222 feet to a stake at corner of lot 145; thence with the line of said lot, S. 9-00 W. 195.5 feet to a stake at corner of lot 107; thence with the lines of lots 107, 106 and 105, N. 74-25 W. 130.4 feet to the point of beginning.

- That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
