to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto DENAS C. GRIER, his Heirs and Assigns, forever:

All that piece, parcel or tract of land in Cleveland Township, Greenville County, State of South Carolina, containing 5.27 acres, more or less, as shown on Plat by J. C. Hill, surveyor, September 27, 1954, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Northwest corner of Lot No. 22, Section A, now owned by the Grantee, and running thence with his line as follows: S. 12-07 E. 41¹/2 feet to an iron pin; thence N. 82-50 E. 191.1 feet to a stake on Sunrise Rock; thence N. 52 E. 113.7 feet to a stake; thence N. 35-30 E. 200 feet to a stake; thence N. 50-30 W. 200 feet to a stake; thence N. 53-30 ... 132.5 feet to a stake; thence S. 36-10 W. 71.5 feet to a stake in the Eastern corner of Lot No. 23 owned by the Grantee; thence in a Northwesterly direction 17¹/₂ feet to a stake in the Northeast corner of Lot No. 21, now or formerly owned by J. J. Humphrey; thence N. 16 ... 36 feet to a stake; thence S. 45-30 E. 17¹/₂ feet to a stake; thence S. 63-30 ... 1/6 feet to a stake; thence S. 50-30 E. 22¹/₂ feet to a stake; thence S. 35-30 ... 272.5 feet to a stake; thence S. 52 ... 117 feet to a stake; thence S. 2-15 E. 2-6.9 feet to an iron pin; thence S. 75 ... 131.5 feet to an iron pin; thence N. 46-50 ... 27¹/₂ feet to an iron pin in pine; thence N. 56 ... 125.3 feet to an iron pin in pine; thence N. 71-30 ... 118.3 feet to an iron pin; thence N. 58-06 ... 150.8 feet to X on rock; thence N. 61-0- E. 148.6 feet to an iron pin in Southeast corner of Lot No. 20 of Frank P. Morris; thence with his line, N. 19-2¹/₂ E. 200 feet to an iron pin on Sunrise Drive; thence with said drive, S. 76-33 E. 20.6 feet to the beginning.
