PARCEL I

S. Highway #25/U. S. Highway #276; thence along the southwesterly right-of-way margin of said Old U. S. Highway #25/ U. S. Highway #276 the following seven (7) courses and distances: (1) South 22° 42' East 96.90 feet to an iron pin found, (2) South 26° 40' East 100.40 feet to an iron pin found, (3) South 32° 10' East 100.25 feet to an iron pin found, (4) South 33° 28' East 100.15 feet to an iron pin found, (5) South 36° 08' East 100.20 feet to an iron pin found, (6) South 38° 29' East 199.00 feet to a concrete right-of-way monument, and (7) South 38° 13' East 323.76 feet to an iron pin found at the POINT AND PLACE OF BEGINNING, containing 15.196 acres as shown on a plat of survey made by Piedmont Engineers, Architects & Planners, entitled "Taylor & Mathis III University Square" certified by James D. Crain, Registered Land Surveyor, and dated July 19, 1975, last revised November 13, 1975.
