1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below

2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein

3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howspever for or on account of that certain real property situated in the County of Greenville , State of South Carolina, described as follows:

All that piece, parcel or lot of land situte, lying and being on the southeastern side of Carolina Ave., in the City of Greenville, County of Greenville, State of South Carolina, and being shown and designated as Lot 10, Block J., EAST HIGHLANDS Subdivision, Section r, on Plat prepared by Dalton & Neves, dated Feb. 1941, recorded in teh RMC Office for Greenville County, S.C. in Plat Book "K", at Page 80, and having according to said Plat the following metes and bounds, Begraning at an iron pin on the southeastern side of Carolina Ive, at the joint front corner of Lots Nos.9 and 10 and running thence with the common line of said Lots S.76-39 E.194.7 feet; thence S.0-24 E.110.0 feet to an iron pin at the joint rear corner of Lots Nos. 10 and 11; thence with the line of Lot No.11 NP63-50 W., 238.3 feet to an iron pin on the southeastern side of Carolina Ave; thence with the curve on the southeastern side of Carolina Ave., the cord of which 18, N.25-14 E.,55.0 feet to the point of beginning. This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, setback lines, roadways, zoning ordinances, easements and rights-of-way, if any, affecting the above described property.

and hereby irrevocably authorize and direct all lessees, escrow holders and others to pay to Bank, all rent and all other monies whatsoever and whenseever becoming due to the undersigned, or any of them, and howseever for or on account of said real property, and hereby irrevocably appoint Bank, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to pattern payment, by suit or otherwise, of all said rents and sums; but agrees that Bank shall have no obligation so to do, or to perform or discharge any coligation, duty or liability of the undersigned in connection therewith.

4. That if default be made in the performance of any of the terms bereof, or if any of said rental or other sums be not paid to bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedmess then remaining unpaid to Bank to be due and payable forthwith.

5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

6. Upon payment of all indebtedness of the undersigned to Lank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unsaid shall be and constitute econclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to gely thereon.
