WITNESSETH:

WHEREAS, by deed dated August 22, 1966 William J. Goldsmith and Henry P. Willimon, as Trustees for Walter W. Goldsmith, Wm. R. Timmons, Jr., William J. Goldsmith and Henry P. Willimon, conveyed to William J. Goldsmith and Henry P. Willimon the following described real estate, to wit:
