

shall at any time be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence; C. These covenants are to run with the land and shall be binding on all parties and all persons claiming under them until January 1, 1991 at which time said covenants shall be automatically extended for successive periods of ten years unless by vote of the majority of the then owners of the lots, it is agreed to change the said covenants in whole or in part; D. Any sewerage disposal system constructed shall meet the approval of the South Carolina Board of Health.


