ALL that piece, parcel or strip of land, in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as a portion of Lot 28 on plat of Knollwood, recorded in the RMC Office for Greenville County, S. C., in Plat Book EE, at Page 35, and also shown and designated as a parcel of irregular shape on plat of Street Relocation Forest Lane in Knollwood Subdivision prepared by C. O. Riddle, dated September 2, 1976, and recorded in the RMC Office for Greenville County, S. C., in Plat Book , at Page , and being more particularly described according to said latter plat as follows:

BEGINNING at a point 19.6 feet from the joint corner of Lot Nos. 27 and 28, on the southerly side of Sunset Drive, and running thence with a new line through Lot No. 28, S. 2-56 E. 39.2 feet to an iron pin; thence S. 35-27 W. 160 feet to an iron pin at the joint rear corner of Lot No. 28 and Forest Lane (proposed); thence N. 48-38 E. 150.15 feet along Forest Lane (proposed); thence with the curvature of Forest Lane (proposed), the chord being N. 3-46 E. 42.2 feet to an iron pin on the southerly side of Sunset Drive; thence with Sunset Drive, N. 41-18 W. 37.4 feet to the point of beginning.

The property conveyed herein is a portion of the property of James Robert Jenkinson, deceased, and devised by his Will appearing in the records of the Probate Court for Greenville County, S. C., in Apartment 436, File 27. Grantors are Trustees under Trust Deed, dated August 28, 1948, and recorded on the same date in the RMC Office for Greenville County, S. C., in Deed Book 357, at Page 278.

It is the intention of this deed, together with deeds of Grantors and Grantee of even date to Wade N. Howard, to relocate in a northwesterly direction the intersection of the street referred to as Forest Lane (proposed) with Support Drive
