

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto WILLEM van der ZALM and JEANNINE R. van der ZALM, their heirs and assigns for ever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Oak Ridge Court, near the City of Greenville, S. C., being known and designated as Lot No. 224 on plat entitled "Map No. 2, Section I, Sugar Creek" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4R, page 85 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Oak Ridge Court, said pin being the joint front corner of Lots 224 and 225 and running thence with the common line of said lots S 49-00-24 E 146.74 feet to an iron pin, the joint rear corner of Lots 224 and 225; thence S 51-48-43 W 152.96 feet to an iron pin, the joint rear corner of Lots 223 and 224; thence with the common line of said lots N 34-52-03 W 162.08 feet to an iron pin on the southerly side of Oak Ridge Court; thence with the southerly side of Oak Ridge Court N 52-15-08 E 46.94 feet; thence continuing with Oak Ridge Court on a curve, the chord of which is N 68-10-16 E 32.23 feet; thence continuing with said Court on a curve, the chord of which is N 63-58-55 E 39.05 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, easements, including a 10 foot drainage easement along side lot lines, and right of ways, if any, affecting the above described property.
