in consideration of the sum of Thirty Five Thousand and 00/100 (\$35,000.00) Dollars,

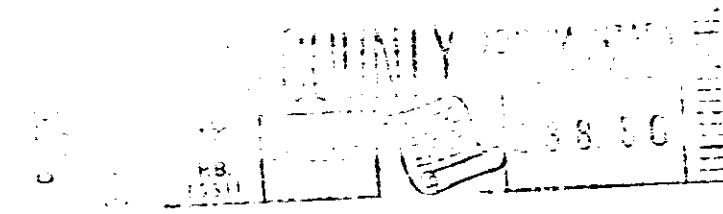
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Michael Frank Talley
