

TITLE TO REAL ESTATE 15

Know All Men by These Presents:

I, Dale E. Hamer, of the County of Greenville, State of South Carolina, for a sum of money to me in hand paid, the receipt whereof is hereby acknowledged, his said sum being Forty-Five Thousand and No/100 (\$45,000.00) DOLLARS, paid to Grantee, Thayer Fleming Grumbine, of the County of Greenville, State of South Carolina, for and in consideration of the sum of money hereinabove mentioned, to the value of these presents, the receipt whereof is hereby acknowledged, his said sum being acknowledged, paid and released, and to these presents does grant, bargain, sell and release unto the said Grantee, her heirs and assigns forever:

All that certain piece, parcel or lot of land, situate, lying and being on the southeastern side of Pimlico Road near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 94 on plat of Section A of Gower Estates made by Dalton & Neves, January 1960, recorded in the RMC Office for Greenville County, South Carolina, in Plat book QQ, Pages 146-147, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Pimlico Road at the joint front corner of Lots Nos. 93 and 94, and running thence along the line of Lot 93, S. 67-54 E. 184.9 feet to an iron pin; thence S. 18-27 W. 65 feet to an iron pin; thence with the line of Lot 95, N. 82-0 W. 181.7 feet to an iron pin on the southeastern side of Pimlico Road; thence with the corner of Pimlico Road, the chord being N. 15-20 E. 110 feet to the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.

This is the same property conveyed to Douglas Hamer, III and Dale E. Hamer by George R. Cousan, Jr. and Laura Clement Cousan, dated April 18, 1972 and recorded in the RMC Office for Greenville County on such date in Deed Book 941 at Page 254 and subsequently devised by Douglas Hamer, III to Dale E. Hamer by will filed in Apartment 1311, File 12 in the Probate Court of Greenville County, South Carolina.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said premises before mentioned unto the Grantee and Grantee's Heirs Successors and Assigns forever. AND Grantor does hereby bind Grantee and Grantee's Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto Grantee and Grantee's Heirs Successors and Assigns against Grantee and Grantee's Heirs and against every person wheresoever lawfully claiming or to claim the same or any part thereof.
