
BOND FOR TITLE

This contract made and entered into by and between David Savink hereinafter referred to as the Seller(s) and Lynn Brandon hereinafter referred to as the Purchaser(s)

WITNESSETH

That in and for the consideration hereinafter expressed, the Seller agrees hereby to sell and convey to the Purchaser and the Purchaser hereby agrees to purchase that parcel of land situate in the County of GREENVILLE, State of South Carolina, 1.75 ACRES OF PINECREST RD., TRAVELERS REST, AS IS EXERCISED BY MR. WILLIAMS, JR. DATED JUNE 22, 1977.



IN CONSIDERATION for said premises, the purchaser agrees to pay to the Seller a total of SEVEN THOUSAND \$7000.00 Dollars for said lot(s) as follows: \$2000.00 DOWN WITH BALANCE OF \$5000.00 FINANCED ON A MONTHLY INSTALLMENT BASIS FOR 36 PAYMENTS AT 7% ANNUAL INTEREST [APR 12, 82] TOTAL PRINCIPAL AND INTEREST \$6800.00 - PAYMENTS \$188.89 EACH TO BE PAID JULY 5TH, SEPT 5TH AND NOV 5TH, 1977 AND REMAINING 33 PAYMENTS IN MONTHS THEREAFTER STARTING JAN 5/78

IT IS UNDERSTOOD AND AGREED, that the Purchaser will pay all taxes upon said lot from and after the date of this contract and will insure all building improvements against loss for the price herein.

In the event any monthly installment is in arrears and unpaid for a period of 30 days, this contract shall, at the option of the Seller, thereupon terminate and any and all payments made by the purchaser prior thereto shall be forfeited by the Purchaser to the Seller as rent for the use of said premises and as liquidated damages for the breach of this contract.

Upon the payment of the purchase price above set forth, the Seller does hereby agree to execute and deliver to said Purchaser a good, fee simple general warranty deed to said property with donor renounced thereon. SUBJECT TO RESTRICTIONS LISTED BY PURCHASER.
