the receipt of which is hereby acknowledged have granted, bargained, sold, and released unto these presents do grant, bargain, sell
and release unto Don T. Rainey and Margaret F. Rainey and their heirs and assigns forever,

ALL that piece, parcel and lot of land, situate, lying and being in the County of Greenville, State of South Carolina, Hick Springs Township, and being known as a portion of that property on plat and survey entitled "Property of Jerry Galloway" prepared by Campbell and Clarkson, Surveyors, Inc., dated March 10, 1971, and to be recorded herewith, and having the following courses and distances, to-wit:

BEGINNING at point on northern side of Buckhorn Road (front corner) and runs thence N. 43-2 E. 525.52 feet to iron pin; thence as rear line, S. 43-2 E. 54.6 feet to new iron pin; thence a new line, N. 21-01 W. 126.1 feet to iron pin on northern side of Buckhorn Road; thence with said road, N. 43-2 E. 54.6 feet to iron pin; thence continuing with road, N. 43-2 E. 100.0 feet to iron pin; thence continuing with road, N. 43-2 E. 147.30 feet to iron pin, the beginning corner.
