ALL that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the northerly side of Piedmont Avenue, being a portion of Lot Nos. 6 and 7 of McCain Heights, addition to Piedmont Park, as shown on plat recorded in the RMC Office for Greenville County, S. C. in Plat Book "J" at page 59, said lot being triangular in shape and being shown on more recent plat entitled "Property of Robert L. Kellett and Elaine Kellett," prepared by R. E. Bruce, RLS, 30 December 1965, and having according to said more recent plat, the following metes and bounds, to-wit:
