BEGINNING at a point located at the edge of the right-of-way of State Road S-331 and the intersection of the entrance to Blue Sky Park Subdivision and running thence along the edge of said right-of-way S. 83-21 W. 555.26 feet to a point; thence continuing along the edge of said right-of-way S. 82-44 W. 243 feet to a point; thence continuing along the edge of said right-of-way S. 78-03 W. 180.1 feet to a point; thence continuing S. 71-39 W. 221.7 feet to a nail and cap in the center line of said right-of-way; thence continuing S. 67-24 W. 200.4 feet to a nail and cap in the center line of said right-of-way at its intersection with State Road S-448; thence turning and running along the center line of State Road S-448 N. 48-19 E. 698.4 feet to a nail and cap; thence turning and running N. 75-18 E. 27 feet to an iron pin; thence continuing N. 67-40 E. 40.2 feet to an old iron pin; thence continuing N. 63-31 E. 26 feet to an iron pin; thence turning and running S. 47-25 E. 253.1 feet to an iron pin; thence turning and running S. 35-12 E. 572.55 feet to a point at the edge of the right-of-way of State Road S-331, the point of beginning.
