It is the intention of the grantor herein by this deed to convey to the grantee herein all rights, title and interest owned by the said John D. Pellett at the time of his death in and to the above described properties.

Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular the said premises unto the said John D. Pellett, Jr. as Trustee of the Residuary Trust under the Will of John D. Pellett, Deceased, his successors and assigns forever in Trust, nevertheless, for the purposes set forth and subject to the terms and conditions stated in the Residuary Trust under the Will of John D. Pellett, Deceased.
