The within described tract of land is conveyed subject to the right-of-way of the Foothills Road as shown on the plat above referred to and is also conveyed subject to any easement or rights-of-way of record or shown on the plat or on the ground.

This is the greater portion of tracts of land conveyed to Edgar Bluford League by two separate deeds; one from George H. Carter and John R.
