Auten and along a course 33' distant from said joint property line S. 21-43 W. 1075.33' to an iron pin; thence along a curved line, the chord of which is S. 16-59 W. 100' to an iron pin; thence continuing along said curved line, the chord of which is S. 7-28 W. 101.1' to an iron pin in the joint line of property of the Grantor and property now or formerly of Lloyd D.
