2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner dispusing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and

3. The property referred to by this agreement is described as follows: All that piece, parcel or lot of land in the County of Greenville, State of South Carolina, being known and designated as Lot 3 of the Sub-division known as Dogwood Terrace, as shown on Plat thereof recorded in Plat Book UU, at Page 05, in the R.M.C. Office for Greenville County, with such metes and bounds as shown thereon.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat, or on the premises.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, or any notes hereof or breafter signed by the undersigned, the undersigned agrees and dies hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge or jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

5. That the Bank may and is hereby authorized and termitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

Upon resiment of all indebtedness of the undersigned to limb this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their beirs, legattes, devisees, administrators executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns.
