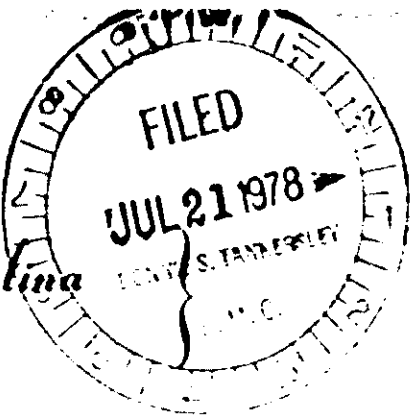

heirs and assigns against itself and its successors, and against every person whomsoever lawfully claiming or to
claim the same or any part thereof, subject, however, to the restrictions and limitations herein contained.
