to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, by these presents do grant, bargain, sell and release unto Glenn R. Barratt, and his heirs and assigns, forever:

All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, on the west side of North Main Street Extension, and being known as the northern portion of Lot No. 10 and the southern portion of Lot No. 9 on plat of North Park Subdivision, recorded in Plat Book "K" at Page 49, and being more particularly described by notes and bounds, as follows:

BEGINNING at an iron pin on the western side of North Main Street Extension, in front line of Lot No. 10, said pin being 29 feet south of the joint corner of Lots 9 and 10, and running thence with the west side of North Main Street Extension, N. 19-46 W. 72.5 feet to an iron pin at corner of lot now or formerly owned by H. B. [unclear]; thence with line of said lot, N. 70-14 W. 160 feet to an iron pin in line of Lot No. 22; thence with line of Lot No. 22, S. 10-46 W. 72.5 feet to an iron pin at corner of lot now or formerly owned by Buford C. Smith; thence with line of said lot S. 70-14 W. 160 feet to the beginning corner.
