




to us in hand paid at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Boyce Lee Solesbee and Sandra Faye W. Solesbee and their heirs and assigns forever:

ALL that certain lot of land in Greenville County, South Carolina, BEGINNING on old stone, running thence N. 31-3. 135.3 feet to iron pin; thence S. 26-55 W. 258 feet to iron pin; thence N. 74-10 W., 448.5 feet to iron pin in road; thence N. 75-45 E. 419 feet to iron pin; thence S. 10 E. 18.5 feet to the beginning, containing 1.4 acres, more or less. Reference is made to Volume 781, page 453, also, plat by J. Q. Bruce, Registered Surveyor, dated January 27, 1959. (Plat book 00 page 205.)
