issues and profits under said leases to the Mortgages without liability to the tenants for the determination of the actual existence of any default claimed by the Mortgagee.

The mortgagee shall have the right to assign the owner's right, title and interest in said leases to any subsequent holder of said mortgage, subject to the provisions of this instrument, and to assign the same to any person acquiring title to the mortgaged premises through foreclosure or otherwise.
