ALL that certain piece, parcel or lot of land, with improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as Lot No. 139 of a subdivision known as Part Two, Chanticleer, Section IV which plat was made by Webb Surveying & Mapping Company dated December 3, 1969 and recorded in the R.M.C. Office for Greenville County in Plat Book 4-F at Page 20 and according to said plat has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Chapman Road at the joint front corner of Lots 138 and 139 and running thence along the line of Lot No. 138, S. 15-39 W., 207 feet to an iron pin; thence S. 44-27 E., 80 feet to an iron pin; thence N. 58-03 E., 104.5 feet to an iron pin; thence along the line of Lot No. 140, N. 9-02 E., 175 feet to an iron pin on the southern side of Chapman Road; thence along Chapman Road N. 81-58 W., 16.5 feet to an iron pin; thence along Chapman Road N. 75-10 W., 103.5 feet to the beginning corner.
