the receipt of which is hereby acknowledged, have granted, bargained, sold, and released and by these presents do grant, bargain, sell and release unto **Frankie H. Smith and Sherri L. Satterfield, their heirs and assigns:**

ALL that certain piece, parcel, or lot of land, situate, lying and being on the southeastern side of Willow Springs Drive, City and County of Greenville, South Carolina, being shown and designated as Lot 7, Block M, Section 6 on a Plat of EAST HIGHLAND ESTATES, recorded in the RMC Office for Greenville in Plat Book O, at Page 109, and having, according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the southeastern side of Willow Springs Drive at the joint front corner of Lots 7 and 8, and running thence with the common line of said Lots, S 74-45 E, 157 feet to an iron pin in the rear line of Lot 1; thence with the rear line of Lot 1, S 18-20 W, 70 feet to an iron pin on a five foot strip reserved for utilities; thence with the northeasterly edge of said five foot reserved strip, N 74-45 W, 186.7 feet to an iron pin on the southeastern side of Willow Springs Drive; thence with said Drive, N 40-45 E, 77.4 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, set back lines, roadways, zoning ordinances, easements and rights of way, if any, affecting the above property.

This is the same property conveyed to the Grantors herein by deed of Mitchell H. Smith, recorded June 25, 1973, in Deed Book 977, at Page 529.
