Mary Kathryn B. Greene, her heirs and assigns forever:

ALL that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina adjoining the lands now or formerly belonging to J. J. and Myrtle M. Gentry, Belue, and Oak Grove Church and more particularly described as follows:

BEGINNING on an old iron pin, a common corner of the Oak Grove Church property and the Belue property, and running thence South 0 deg. 45' East 221.8 feet South 65 deg. 15' West 106 feet to a nail in the center line of said road; thence South 78 deg. 45' West 234 feet to a nail in the center line of said road designated by an iron pin offset North 6 deg. 47' West 23 feet from said nail; thence North 6 deg. 47' West 240 feet to an iron pin; thence North 77 Deg. East 200.2 feet to an iron pin, a common corner to the J. J. Gentry and Belue properties; thence North 47 deg. 30' East 207.9 feet to the BEGINNING, containing two acres, and shown and delineated upon a plat entitled, "Land Survey for J. J. Gentry and Myrtle M. Gentry," dated June 7, 1963, prepared by J. Q. Bruce, Registered Surveyor.


