ALL that piece, parcel and lot of land, situate, lying and being in the County of Greenville, State of South Carolina, Highland Township, and being shown on new survey and plat entitled "Survey for David R. Foster" prepared by Wolfe & Huskey, Inc., dated July 17, 1973, containing 1.5 acres, more or less, said plat to be recorded herewith, and having, according to said plat, the following notes and bounds, to-wit:

BEGINNING at RR Spike in center of County Road, joint corner with Henson line, and runs thence along said Henson line, S. 47-41 E. 293.9 feet to old iron pin; thence as a rear line (new Line) S. 08-35 W. 191.9 feet to new iron pin; thence as new line along other property of grantor, N. 67-18 W. 295 feet to RR Spike in center of County road; thence along center of said road, N. 16-58 E. 236.2 feet to beginning corner.
