KNOW ALL MEN BY THESE PRESENTS, that I, Louise B. Batson,



ALL That certain piece, parcel or lot of land situate, lying and being in Greenville County, state of South Carolina, near the corporate limits of the city of Greenville in what is known as Sterling Annex, the lot hereby conveyed having the following metes and bounds, courses and distances:

BEGINNING At a point on Maloy Street 75 1/2 feet from the northeast corner of Maloy and Valentine Streets and running thence N. 48-25 E. 33 1/2 feet along Maloy Street to an iron pin; thence S. 42-50 E. 146.8 feet to an iron pin; thence S. 48-50 W. 18 feet to a stake; thence in a straight line to the beginning corner on Maloy Street.
