in consideration of --Ten Dollars and Love and Affection for my wife, Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jewel F. McCall and her heirs and assigns forever,

ALL that certain piece, parcel or lot of land, lying and being in the State and County aforesaid, near Cross Roads Baptist Church, lying on the northern side of the Bennett's Bridge Road, being bounded on the north and west by lands of J.H. McCall, on the east by lands of League, and on the south by said road and being described as follows

BEGINNED on an iron pin on the north side of the said road (hickory tree), joint corner of the League land, and runs thence with the League line, N. 29-45 E. 275 feet to an iron pin on the said line; thence a new line, S. 78-04 W. 401.3 feet to an iron pin, new corner; thence another new line, S. 3-30 W. 250 feet to a nail and stopper in the said Bennett's Bridge Road (iron pin back on line at 17 feet); thence with the said road, S. 87-30 E. 63 feet to a point in the southern edge of the road; thence N. 69-15 E. 147.3 feet to a nail and stopper in the center of said road, joint corner of the League lands and others; thence N. 57-45 E. 83 feet to the beginning corner, containing 1.31 acres, more or less.

This conveyance is subject to all restrictions, easements, rights of way, roadways and zoning ordinances of record, on the recorded plats or on the premises.
