KNOW ALL MEN BY THESE PRESENTS, that JOHN W. MATTHEWS, JR. AND JOY R. MATTHEWS

in consideration of FORTY FIVE THOUSAND, FIVE HUNDRED AND NO/100 (\$45,500.00) ----- Dollars  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HAROLD ALLEN, his heirs and assigns:

ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the southwestern side of Windemere Drive, in Greenville County, South Carolina, being known and designated as Lot No. 30 on a plat entitled Map No. 2 Cherokee Forest made by Dalton & Neves, dated October 1956, recorded in the RMC Office for Greenville County, S. C. in Plat Book EE at page 191, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Windemere Drive at the joint corners of Lots Nos. 29 and 30 and running thence with the common line of said lots, S. 73-01 W., 236.9 feet to an iron pin in the rear line of Lot No. 74; thence along the common line of Lots Nos. 30, 72, 73 and 74, S. 41-30 E. 244.2 feet to an iron pin at the joint rear corner of Lots Nos. 30 and 31; thence along the common line of said lots, N. 56-30 E., 198.1 feet to an iron pin on the southwestern side of Windemere Drive; thence along the southwestern side of Windemere Drive, N. 36-20 W., 100.1 feet to an iron pin; thence continuing along the southwestern side of Windemere Drive, N. 33-30 W., 73.3 feet to an iron pin the point of BEGINNING.

The above property is the same conveyed to the grantors herein by deed of John W. Matthews, Sr. and Frances Howard Matthews recorded in Deed Book 993 at page 843 on February 15, 1974, and the same is hereby conveyed subject to rights of way, easements, conditions, roadways, setback lines and restrictive covenants reserved on plats and other instruments of public record and actually existing on the ground affecting said property.

The grantee agrees and assumes to pay Greenville County property taxes for the tax year 1978 and subsequent years.

This property is subject to a portion of a Duke Power Company transmission line right of way 100 feet in width affecting the northernmost side boundary line, as shown on the recorded subdivision plat.
