
ALL that piece, parcel and tract of land in said County and State, Mead Township, fronting on Croce Meadow Road, and being shown and designated by survey, and plat (NOT RECORDED), prepared by Lindsey, Lewis, dated 1-6-71, entitled "Survey of Jerry Ballou and Ruth Hollifield, and having, according to said plat, the following notes and terms:

BEGINNING at the northern portion of our lands, in center of said road, and runs thence, S. 23-44 E. 190.77 feet to point in center of road; thence continuing with center of said road, S. 27-16 E. 111.35 feet to a point in center of said road; thence a new line, S. 01-38 E. 506.02 feet to a point; thence N. 30-57 E. 157.3 feet to a point; thence N. 75-56 E. 100.0 feet to a point; thence N. 30-46 E. 100.0 feet to a point; thence N. 3-37 N. 99.68 feet to a point; thence N. 77-30 E. 175.31 feet to a point in center of said road, the beginning corner, containing 2.0 acres, more or less.
