REAL PROPERTY AGREEMENT

Ach loans and indebtedness as shall te made by or become due to the FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION of Greenville, S. C. (hereinafter referred to as "The Association" to or from the undersigned, ____ Roscoe Hines and Frances G. Hines jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of The Association, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and
- 3. Hereby assign, transfer and set over to The Association, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise, and howscever for or account of the certain real property situated in the <u>Greenville</u> ___, State of South Carolina, described as follows:

On the southwestern side of Augusta Road and being known and designated as Lot No. 7 on a plat entitled "C. F. Cammer Property", plat of which is recroded in the RMC Office for Greenville County in Plat Book "L" at Page 115, and having, according to said plat, the following metes and bounds, to-wit: Beginning at an iron pin on the southwestern side of Augusta Road at the joint front corner of Lots 7 and 8 and running thence with the common line of said Lots S. 53-33 W. 261.6 feet to an iron pin at the joint rear corner of said Lots, thence N. 36-24 W. 89.5 feet to an iron pin at the joint rear corner of Lots 6 and 7, thence with the common line of said Lots N. 53-33 E. 269.5 feet to an iron pin on Augusta Road, thence with said Road S. 31-18 E. 90 feet to the point of beginning.

and hereby irrevocably authorize and direct all leasees, escrow holders and others to pay to The Association, all rent and all other monies whatsoever and whensoever becoming due to the undersigned, or any of them, and howsoever for or on account of said real property, and hereby irrevocably appoint The Association, as attorney in fact, with full power and authority, in the name of the undersigned, or in its own name, to endorse and negotiate checks, drafts and other instruments received in payment of, and to receive, receipt for and to enforce payment, by suit or otherwise, of all said rents and sums; but agrees that The Association shall have no obligation so to do, or to perform or discharge any obligation, duty or liability of the undersigned in connection therewith.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to The Association when due, The Association, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to The Association to be due and payable forthwith.
- 5. That The Association may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as The Association, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to The Association this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of The Association and its successors and assigns. The affidavit of any officer or department or branch manager of The Association showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
