An Easement and Right of Way in and over the premises described hereinbelow for use in the operation and maintenance of a golf course and for all incidental purposes relating thereto including, but not limited to, golf cart paths and irrigation systems.

Office for Greenville County in Plat Book QQ at Page 168 and running thence the following courses and distances: S. 69-45 W. 126.29 feet to an Iron pin, thence N. 20-42 W. 62.88 feet to an iron pin, THE POINT OF BEGINNING; and running thence from said point of beginning S. 69-18 W. 151.69 feet to an iron pin; thence S. 44-54 W. 197.37 feet to an iron pin; thence S. 67-20 W. 467.98 feet to an iron pin; thence N. 22-40 W. 15 feet to an iron pin; thence N. 67-20 E. 465 feet to an iron pin; thence N. 44-54 $\stackrel{\frown}{\sim}$. 197.64 feet to an iron pin; thence N. 69-18 E. 154.93 feet to an iron pin; thence S. 20-42 E. 15 feet to the point of beginning.
