in consideration of Fourteen Thousand Nine Hundred and NO/100 (\$14,900.00) Dollars,


the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wilma K. Trammell, her heirs and assigns, all my one-half interest in and to:

"ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the Southeastern side of Hodgens Drive, near the City of Greenville, South Carolina, being shown as Lot No. 4 on a plat entitled "Ogden Acres", prepared by Carolina Engineering & Surveying Co., dated September 25, 1964, and recorded in the R.M.C. Office for Greenville County in Plat Book BBB, at Page 27, and having according to said Plat the following metes and bounds, to-wit:

— 305 - B 13, 1 - 1-124 NOTE

BEGINNING at a point on the Southeastern side of Hodgens Drive at the joint front corner of Lots Nos. 4 and 5 and running thence with the line of Lot No. 5, South 33-43 East 140 feet to an iron pin on the line of Lot No. 2; thence with the line of Lot No. 2, North 56-17 East 108 feet to an iron pin on the line of Lot No. 1; thence with the line of Lots Nos. 1 and 3, North 33-43 West 140 feet to an iron pin on the Southeastern side of Hodgens Drive; thence with the Southeastern side of Hodgens Drive, South 56-17 West 108 feet to the point of BEGINNING."

This being a one-half interest in that certain property conveyed to James R. McClain and Doris S. McClain by Deed of Henry C. Harding Builders, Inc., dated August 4, 1965, and recorded in the R.M.C. Office for Greenville County, South Carolina, on the 4th day of August, 1965, in Deed Book 779, at Page 259.
