Dollars and assumption of mortgage as hereinbelow set out, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles O. Ferguson and Christine Jackson Ferguson, their heirs and assigns forever:

ALL that lot of land in the State of South Carolina, County of Greenville being known and designated as Lot 28 on a Plat of Trammell Heights, recorded in Plat Book EE, at Page 28, and having according to said Plat the following metes and bounds, to-wit:
