Sloan, her heirs and assigns, forever All that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, containing 100 acres, more or less, and being a part of a tract designated as Tract 1 on a plat of the Estate of G. W. Austin made by J. Middle, Eng. February 1, 1933, and recorded in Plat Book "L" at page 159, and having according to said plat the following notes and bounds:

Beginning at a stake on the South bank of Reedy Fork Creek, at corner of lands now or formerly belonging to Tom Coxer and running thence with Coxer line, S. 35-00 W., 1985 feet to a stake; thence continuing S. 35-30 W. 835 feet to stone; thence continuing S. 34-45 W. 1370 feet to a point in the center of a public road; thence continuing with the center of the public road in a Northwesterly direction 1050 feet, more or less, to a point on the boundary of the tract designated as Tract 1 and the tract designated as Tract 2 on the Estate of G. W. Austin, referred to above; thence continuing N. 23-35 E. 2971 feet to stake in center of small branch; thence continuing with said branch as the line the following courses and distances: S. 79-15 E. 117 feet; N. 2-45 E. 170 feet; N. 46-45 E. 160 feet; N. 59-15 E. 162 feet to point in center of said branch where said branch empties into Reedy Fork Creek; thence down said Reedy Fork Creek as line S. 42-45 E. 3'0 feet; N. 2-00 E. 500 feet; S. 70-15 E. 4'0 feet to stake on South bank of Reedy Fork Creek, the beginning.
