All of that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the Southeast side of the Thompson Road (also known as South Parker Road) near the City of Greenville, in the County of Greenville, State of South Carolina, being known as Lot No. 20 on the revision of a plat of Hillendale Estates, property of L. A. Noseley, revised by C. C. Jones, Engineer, April, 1948, and recorded in the R. M. C.
