to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Spacial Chemical Company Inc., its successors and assigns forever: Donaldson Center, Greenville, S.C.

All that certain place, parcel or lot of land lying and being in the County of Greenville, State of South Carolina, Gantt Township, in Donaldson Center on the eastern side of Perimeter Road and having according to a plat prepared by J. L. Montgomery III, R.I.S., April 26, 1973, the following rates and bounds to wit:

This conveyance is made subject to restrictions and protective covenants, dated September 5, 1969, and recorded in the R.M.C. Office for Greenville County in Deed Volume 875, page 117, the portions thereof which are applicable to the above-described property being Clause III, General Requirements: Section A, Specifically Prohibited Uses, numbers I through 21; and Section B, Use of Land and Buildings. This conveyance is also subject to the following additional covenants, the first three of which are to be uniformly imposed upon the Air Park, Engineering and Research Sections of Donaldson Center Industrial Air Park, Donaldson Center, as follows:

a. The outside walls of any and all buildings or other structures erected or constructed on the premises shall be of face brick or such other fireproof or fire-resistant material which may be approved in writing by the Donaldson Development Commission.

b. No building or structure of any kind, including but not limited to walls, fences, and signs, shall be erected, altered, placed, assembled, (over) two feet in height and visible from the public areas, buildings and approaches, and prohibited to be in any way built or supported, to have and to hold all and singular the property of record, and to the grantee, and the grantee's heirs, executors and administrators, to warrant and forever defend all and singular rights, title, and interest in and to the above described premises and against every person whomsoever lawfully claiming to have the same or any part thereof.
