ALL that certain lot or tract of land located near the Town of Simpsonville, Greenville County, South Carolina, containing 2.85 acres, being shown as Lot 4 on a Plat of Property of E. G. Whitmire, Jr., by C. O. Riddle, dated December 2, 1970, and having, according to said Plat, the following metes and bounds:
